Terms and Conditions 1. Acceptance

By appending your signature to this application form, it shall be deemed as acceptance to the Internet Banking Terms and Conditions below, and in the event of omitting to sign, the customer shall be deemed to have accepted the Terms and Conditions upon receipt of internet banking credentials.

2. Losses

- i. Metbank shall not be held liable for any losses or damage, direct or indirect, actual or contingent, arising from the failure of internet connectivity. It shall be your to ensure that your computer device is secure and internet browser is optimal for such services, and indemnify Metbank in respect of any losses arising as a result of delays beyond Metbank's control in processing of transfers.
- ii. You are responsible for the accuracy and completeness of your internet instructions and ensure that they will achieve your intended purpose. Metbank shall not be liable for any loss or delay where the contents of the customer's instruction are inaccurate or incomplete.

4. Cancellation of Internet Banking Facility

- i. You are obliged to advise Metbank in writing if you no longer wish to use the Metbank Internet Banking facility.
- ii. If you suspect that your Internet Banking credentials have been compromised, you can notify Metbank to deactivate them orally and this notification should be followed up immediately with a written notification. All transactions done prior to the notification shall be deemed to have been made.

5. Cancellation of Internet instruction(s)

- i. Your instructions involving a payment via Metbank Internet Banking cannot be cancelled except for forward dated transfers only, as these can be canceled before the forward date arrives.
- ii. If you request to cancel any instruction, Metbank will make all reasonable efforts to comply with your request.
 However, Metbank shall not be liable for any failure to cancel your instruction should there be reasons to do so, or should the request be received under circumstances that render Metbank unable to comply with the request.

6. Suspension or Termination of Internet Service

In order to protect you and Metbank, Metbank shall be entitled to immediately suspend or withdraw all or some of the internet services, if the service is being used contrary to the Terms and Conditions of this agreement and also if Metbank has reasonable grounds to believe that the internet service is being used negligently or fraudulently.

7. Internet Service Hardware maintenance and security

- i. It is your responsibility to set up, maintain and regularly review security arrangements concerning access to, and use of, the internet service, and information stored on the device you are using to access Metbank internet banking service.
- ii. You acknowledge that information transmitted through the internet or any other communication system which includes wireless communication is susceptible to unlawful access, distortion and monitoring and that you use the internet banking at their own risk.
